We believe our donors deserve full transparency on how their money is allocated in pursuit of our mission to improve the lives and seek cures for those affected by ichthyosis and related skin types.

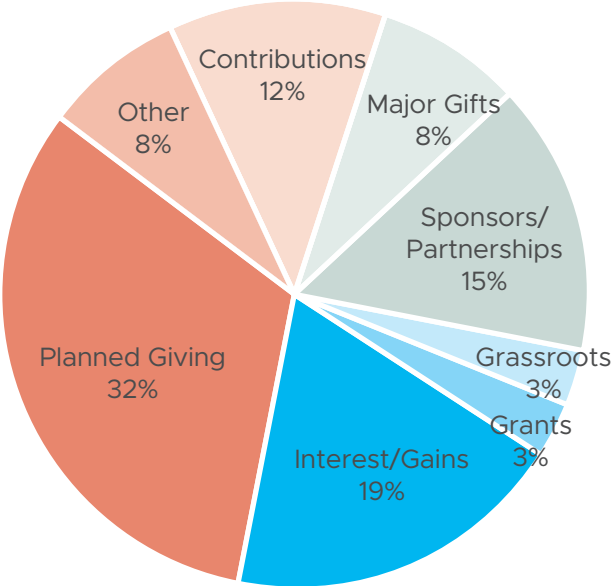

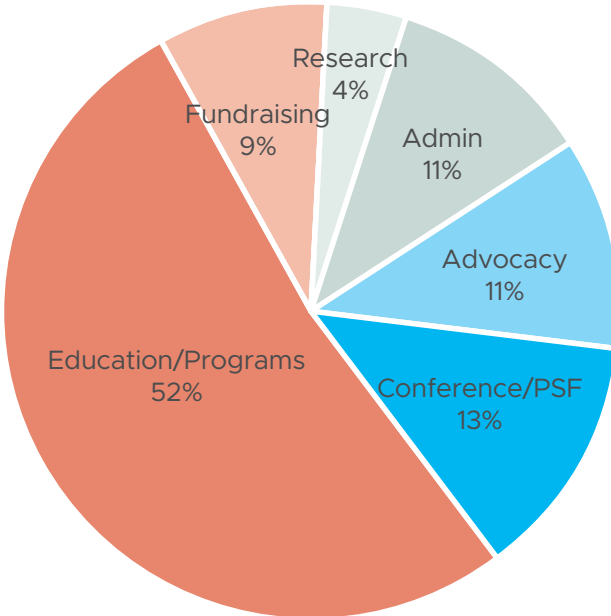
